

NERC Certification: Exam Preparation Program

Instructor-Led Training

The SOS Intl NERC Certification: Exam Preparation Instructor-Led Training is part of a curriculum for new personnel to obtain their NERC System Operator Certification. In conjunction with the other program components – NERC Pre-Assessment Evaluation, NERC Certification: Exam Preparation Online and End-of-Program Exam – the Instructor-Led training course provides effective instruction in the basic principles of the Bulk Electric System (BES) and the NERC Reliability Standards applicable to System Operators.

Non-certified Operators

For students who are preparing to take the exam, this course is designed to supplement the online portion of the program. In an intensive three-day review of exam preparation material, students will get ready for the exam and identify areas where more study is needed. In addition, they will leave the course with test-taking tips, study hints, and a variety of resources giving them an added edge in taking the NERC Exam. Our goal is to help students pass any of the four NERC System Operator Certification Exams:

- Reliability Operator
- Balance and Interchange Operator
- Transmission Operator
- Balancing, Interchange, and Transmission Operator

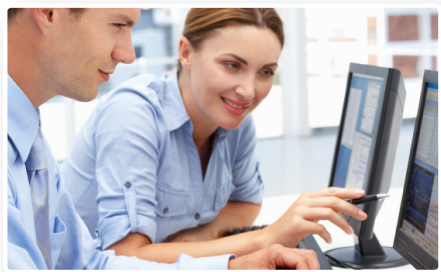
Certified Operators

For those students who are already certified, the Instructor-Led course will provide a refresher of the NERC Reliability Standards applicable to System Operators and how they apply to the operations of the power system.

The SOS NERC Certification Instructor-Led Training covers the following:

- Resource and Demand Balance
- Interchange Scheduling and Coordination
- Transmission Operations
- Voltage and Reactive Control
- Protection and Control
- Interconnection Reliability Operations and Coordination
- Emergency Preparedness and Operations
- System Operations

The effectiveness of this course depends on its completion with the Pre-Assessment Evaluation, NERC Certification: Exam Preparation Online and End-of-Program Exam. This course is one component of an overall program to help students pass their exam.



Online Training

The online program is based on the current NERC Certification Content Outline, providing a good foundation of prerequisite knowledge for exam candidates.
